Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. DATA RATES MAY APPLY TO ENTRIES MADE VIA MOBILE DEVICE. INTERNET ACCESS REQUIRED.

THE SWEEPSTAKES IS OPEN ONLY TO LEGAL RESIDENTS OF THE U.S. RESIDING IN THE STATE OF WISCONSIN, WHO ARE EIGHTEEN (18) YEARS OF AGE OR OLDER AT TIME OF ENTRY. 1. SWEEPSTAKES PERIOD: Sweepstakes begins at 12:00 a.m. Central Time ("CT") on June 1, 2025 and ends at 11:59 p.m. CT on August 16, 2025 ("Sweepstakes Period"). The time clock of the Sweepstakes Administrator's computer (defined below) is the official timekeeping device for the Sweepstakes.

2. HOW TO ENTER: During the Sweepstakes Period, you can enter via the following methods: **(a) SCAN THE QR CODE:** Use your smart phone, or internet enabled device, to scan the QR code located on Pepsi 12oz cans. Follow the on-screen instructions for registering, properly completing, and submitting an entry. Participants must have a smart phone or other web-enabled device with a camera feature or code-reader application and may incur standard data charges from their wireless service provider. Check with your wireless service provider for details on any applicable charges. Participants are solely responsible for any such wireless charges. Not all wireless carriers participate. By entering this Sweepstakes the entrant is consenting to receive text, phone, and/or email messages regarding the Sweepstakes; **(b) INTERNET:** Visit www.forwardmadisonfc.com/pepsi-fmfc-vip-contest/ and follow the on-screen instructions to properly complete and submit an online entry by August 16, 2025.

Limit one (1) entry per person/email address per day, regardless of method of entry. A "day" is defined as a twenty-four (24) hour time-period beginning at 12:00:00 a.m. (midnight) CT and ending at 11:59:59 p.m. CT of the same day. The time clock of the Sweepstakes administrator is the official clock for this Sweepstakes.

All entrants must have a valid email address. The name of the person submitting the entry into the Sweepstakes must be the authorized account holder of the email address used to enter, otherwise, entry may be deemed void. Multiple entrants may not share the same email address. In the event of a dispute over the identity of an entrant, entry will be declared to be made by the authorized account holder of the email address used during the entry process. A potential winner may be required to provide identification sufficient to show that they are the authorized account holder of such email address.

Each entry must be manually keystroked and/or manually entered by the individual entrant. 5. RANDOM DRAWING: Potential winners will be selected in a random drawing from among all eligible entries received throughout the Sweepstakes Period. Odds of winning depend upon the total number of eligible entries received. Drawing will occur on or about August 20, 2025. All prizes will be awarded. Sponsor's decisions as to the operation of the Sweepstakes and the selection of the potential winners are final and binding in all matters related to the Sweepstakes.

6. WINNER NOTIFICATION: Potential Sweepstakes winner(s) will be notified by the Sponsor via email at the email address provided upon entry within two (2) business days of the drawing date, and will be required to claim the prize (by providing his/her phone number and/or mailing address, if not already provided) within seventy-two (72) hours or prize may be forfeited and awarded to an alternate winner. If (a) a potential winner does not properly claim their prize (as instructed in the Notification); (b) a Notification or prize is returned as undeliverable; or (c) a potential winner cannot be verified or is otherwise unable to accept the prize as stated, prize may be forfeited and awarded to an alternate winner at Sponsor's sole discretion. Any portion of a prize not accepted by winner will be forfeited. Upon forfeiture for any reason as stated in these Official Rules, no compensation will be awarded.
