I, the participant, fully understand, appreciate and agree that I am voluntarily requesting to participate in bringing my dog to Canines at Cashman (the "Event") to Cashman Field in Las Vegas, Nevada (the "LVFC"), which will involve my attendance and the attendance of my dog of which I have custody as well as other dogs in the custody of others. I acknowledge, agree, and represent that I have, or will immediately upon entering and continuously thereafter, inspect the either the Berm and/or Section 22 where I will be permitted to watch the game with my dog and determine that it is safe and suitable for my dog's participation in the Event and further agree and warrant that if, at any time, I determine anything to be unsafe, including the threat from other dogs participating in the event, I will immediately advise a Las Vegas Lights FC official of such unsafe condition(s) and will leave Cashman Field with my dog. I understand that inspection will include walking from the parking lot to the Berm/Section 22.

I acknowledge that the activities of the Event can be dangerous and could involve the risk of serious injury, death, or damage to me, my dog, others, and others' dogs. I acknowledge that injuries received may be compounded or increased by negligent rescue operations or procedures of the Released Parties identified below. I understand that my actions and the actions of the dog of which I have custody and control during the Event or dogs owned or in the custody of other participants may result in injuries and damages to myself and others, whether anticipated or unanticipated, or foreseeable or unforeseeable, including my dog as well as dogs of others by participating in this Event. I understand that I assume the risk and responsibility for any and all risks associated with participating in this Event, including but not limited to human injury, death, and property damage, as well as injury, death, and property damage to dogs. I agree to abide by any decision of any LVFC official relevant to my ability or the ability of the dog of which I have custody to participate in this Event safely, and I further agree that LVFC officials may authorize necessary treatment for me and/or the dog in my custody.

I further understand and assume any and all risks associated with my participation in this Event, including but not limited to illness, traveling to and from the Event, falls, contact with spectators at the Event, injuries or damages of any kind, including death sustained by and through other participant dogs, the effects of the weather including extreme heat, and/or the condition of the premises and Cashman Field, including but not limited to sidewalks and parking lots.

I confirm and assure that my dog has current Rabies, Distemper, Parvo, and Bordetella vaccinations, is in good health, is able to tolerate the presence of crowds and other dogs and is not dangerous or aggressive towards people or other dogs. I agree to abide by all the rules and instructions given in connection with this Event. I assume the risk for injuries and damages sustained as a result of the manner and method by which the Event is administered.

In consideration for allowing me to participate in this Event, either with my dog in my custody and control or attending the Event without a pet, I agree, for myself, my dog, and for any minor child accompanying me to the Event, and all of our respective heirs, legatees, executors, administrators, successors and assigns, or anyone acting on our behalf ("Releasers"), to forever waive, release, and discharge Las Vegas Soccer, LLC (the "LVFC"), and all of their respective parents, subsidiaries, affiliates, related entities, sponsors, officers, directors, employees, agents, officials, partners, managers and shareholders, and other personnel or entities in any way assisting or connected with this Event (together the "Released Parties"), from any and all claims, demands, causes of action, proceedings, losses, damages, liabilities, costs and expenses (in all cases including reasonable attorneys' fees), of any kind or nature, that relate to or arise in any way from attendance at or participation in the Event by me, my dog, and/or any minor child accompanying me, expressly including any claims arising from any NEGLIGENT acts, omissions, or conduct of the Released Parties ("Claims"). I further covenant not to sue or otherwise pursue any form of recovery or legal action, including arbitration, against any of the Released Parties and arising from or relating to any Claims.

I further agree that I am solely responsible for any claim for personal injury, injury to a dog, or property damage made by any third party and based in whole or in part on my, my dog's, and my minor child's attendance at or participation in the Event ("Third Party Claims"). In particular, I agree to pay all cleaning or repair costs resulting from any damage to Cashman Field caused by me, my minor child or my dog. I further agree to defend, indemnify and hold harmless any of the Released Parties from any allegation, action, or lawsuit brought against any of the Released Parties by a third party and based in whole or in part on a Third Party Claim(s) that relate to or arise in any way from attendance at or participation in the Event by me, my dog, and/or any minor child accompanying me, even those caused by the NEGLIGENT acts, omissions, or conduct of the Released Parties.

I agree to grant LVFC or their designees, without further compensation, an unrestricted, worldwide license in perpetuity to use, without further notification, the name, voice, image, likeness, actions and statements of me or any minor child and/or dog that accompanies me to the Event, for any purpose, including but not limited to advertising, promotional or commercial purposes, in any media known or hereafter developed. I represent, for both me and my minor child(ren), that I am at least eighteen (18) years of age, and I am competent to sign and agree to this Waiver, Indemnification, Release of Claims and Covenant Not To Sue and License with full understanding of the above information. In addition, I represent that I am legally authorized to sign this document on behalf of any accompanying minor child(ren). The undersigned participant further expressly agrees that this Agreement is intended to be as broad and inclusive as is permitted by the law of the State of Nevada and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

BY SIGNING THIS, I ACKNOWLEDGE THAT (i) I HAVE READ AND AGREE TO THIS WAIVER, INDEMNIFICATION, RELEASE OF CLAIMS AND COVENANT NOT TO SUE AND LICENSE, (ii) I HAVE READ AND AGREE TO THE BARK IN THE BERM RULES AND INFORMATION, (iii) I HAVE VOLUNTARILY SIGNED BELOW, AND (iv) NO ORAL REPRESENTATIONS, STATEMENTS OR INDUCEMENTS APART FROM THE FOREGOING WRITTEN STATEMENT HAVE BEEN MADE OR OFFERED TO ME BY THE RELEASED PARTIES.
