

**Centreville Bank Stadium Tailgating Polices**  
**Applicable only to Lot M7**  
**2025 Season**

**These policies are only enforced in Lot M7 operated by Centreville Bank Stadium.**

**This lot is open to pre-sold pass holders and event day parking spot sales.**

- Tailgating lot is normally open three hours prior to the event start time unless schedule conflicts occur
- One spot per vehicle per spot sold.
- A ticket holder who may be in possession of more than one parking pass will be allowed to use adjacent spaces for tailgating per space regulations.
- Please be considerate of your fellow ticket holders. Tailgating will be limited to the lined parking space. The blocking of the drive lane is prohibited.
- You must keep all tables, chairs, coolers, barbeques, etc. within the parking stall of your party. Tents or canopies exceeding 8' x 8' footprint and vehicles measuring more than 16' in length and/or 8' in width are not permitted to park in a lined parking space.
- Tailgating is also permitted on the medians that separate the parking lots from the roadways but cannot impede the pedestrian sidewalks.
- First come, first serve; saving spots will not be allowed. If you would like to tailgate near friends, please arrive together.
- All cooking equipment shall be situated away from crowds, buildings, vehicles or combustible materials. A minimum clearance of 3 feet is required
- Liquid charcoal starters or other flammable liquids are prohibited
- Quick starting charcoal is recommended
- Open flames are permitted, but all barbecue equipment left unattended must be extinguished
- Ash containers, Trash containers, and Port-O-Lets are in the lot
- Hot ashes, cinders, smothering coal, disposable LP-gas cylinders or other hot materials must be disposed of in specified dumpsters

- Parking lot management will provide two bags to each vehicle upon entry into the parking lot. One bag will be for refuse items, and the second bag will be for recyclables. Trash bags must be disposed of in the specified receptacles.
- Glass containers are not permitted
- Centreville Bank Stadium and Rhode Island FC do not allow advertising, banners, signs or distribution items for promotional use on property. Tailgaters may be asked to remove inappropriate banners or signs. Guerrilla Marketing is strictly prohibited. Sales of any kind are not permitted in the lot.
- Music speakers may not exceed reasonable levels in the sole determination of Centreville Bank Stadium Management and/or applicable City of Pawtucket ordinances.
- Alcoholic beverages in open containers will not be permitted outside of the parking premises of Lot M7. If a guest(s) possesses an alcoholic beverage(s) on public property (street, walkways, etc) they are subject to fine and/or arrest by law enforcement.
- For safety purposes, all tents, chairs, etc. must be put away before entering Centreville Bank Stadium.
- Parking pass holders are normally welcome to continue tailgating up to one hour after the end of the event. In some instances, guests may be asked to clear the parking lots before that time due to scheduling limitations.
- Please drink responsibly during the pre-event since guests who appear to be impaired may not be permitted to enter the stadium.
- Tailgating must conclude 30 minutes prior to the event start time. After an event concludes, post-event tailgating must conclude one hour after the event ends. Tailgating after the conclusion of events with a starting time of 6:00 P.M. or later is strictly prohibited.
- **Centreville Bank Stadium and/or Rhode Island FC reserve the right to revoke a parking pass holder at any time for failure to adhere to these guidelines.**
- **Lot M7 is private property, and the property owner's allowance for any such tailgating activities can be revoked at the property owner's discretion. Please be respectful of our neighbors.**
